### **JUDGING CRITERIA**

Is as per the scholarship criteria.

### **AWARD PRIZES**

- All scholarship winners will be provided a place in ALUCA foundational industry certificate in either the Life insurance Underwriting certificate course or the Life insurance Claims management certificate course
- On successful completion of the certificate, if the winner is eligible, they will be able to become an accredited ALUCA CPLI Affiliate member and the use the CPLI post nominals.

### **TERMS & CONDITIONS**

The scholarships provided: are for an online foundational life insurance certificate. Entrants must state if they want the life insurance underwriting or claims certificate. The package does not include any other associated costs.

1. The scholarships are open to all members of ALUCA regardless of country of residence. Each entrant must be a current financial member of ALUCA. Entrants must work in the life insurance industry. Individual entry is not open to members of the ALUCA National Board.

ALUCA may change, amend or vary these terms and conditions and may extend the period of, or cancel, the Life insurance Scholarships without notice. All details are strictly confidential.

4. Entrants in the scholarship must ensure they have included their name and telephone contact details including mobile phone. Each entrant must include the word count for Q6 on their application.
